 Treatment (therapeutic) foster care (TFC) is a residential intervention for youth with mental illness or behavioral problems which are significant enough to need out of home placement. Trained treatment parents (call Family Teachers) work with youth in their homes to provide a structured therapeutic environment while also providing opportunities for the youth to live in a family setting and learn how to live, work, and get along with others. Youth Quest has evidence of its treatment as an empirically supported treatment (EST).
 Family Foster Care is also provided to youth who are in the custody of the state of North Carolina who are in need of a foster home, and who do not meet medical criteria for therapeutic foster care. All our family foster care Family Teachers are also certified as therapeutic foster parents.
 Youth Quest is a licensed child placing agency nationally accredited by the Council on Accreditation or COA.
