There is no cost to our honored guests for any of these items or services. The good news of the gospel of Jesus Christ is always given freely in both English and Spanish during the initial welcome of our honored guests. Every volunteer strives to extend the love of Jesus Christ throughout the visit of each and every honored guest that we serve (and everyone who enters our facility is seen as an honored guest).

With Love from Jesus Ministries is continually reviewing our operations and expenditures in order to keep our administrative costs as low as possible so that we can focus on our ministry goal. The Board of Directors is provided with revenue and expenditure account summaries each month, and prior year information is provided in the same Excel spreadsheet by email transmittal. Employees working for the ministry are overseen on a daily basis by our on-site Executive Director or her managerial designee. Compensation for our employees is reviewed annually against that of similar organizations to help ensure that our costs in this area bring only credit to Him in whose name we serve. Our commitment to integrity and transparency is seen through our membership in the Evangelical Council for Financial Accountability (ECFA) and information on our costs as provided through our Form 990 and supplemental schedules can be viewed at www.ECFA.org or by doing a search on our corporate name.

With Love from Jesus Ministries operates out of approximately 20,000 square feet in an old and gutted grocery store. While we have lights and electricity, our space has no heating or air conditioning. We continue to strive to be good stewards of the resources that God has richly provided us with. Without heat and air conditioning, the concrete floors and lack of window ventilation causes some sacrificial challenges for our volunteers and staff. However, we are blessed through coming together as the body of Christ and serving in His name.
