

5,622 clients were assisted with the following needs - utilities, rent, mortgage, transportation, medical expenses, and food. The largest need by dollars spent was utilities at 77.4% of benevolence funds distributed in 2012. The largest need by individuals served was food at 82.2% of clients served in 2012. Individuals are interviewed 2-4 mornings each week to determine need for assistance and to verify all information. Food is distributed up to six hours per week with verification of identity, family size, and health or age-related issues.
