BQLI-AHEC operates four core programs The Summer Health Internship Program provides high school students with professional and academic experiences in the health care field The program places students in six-week placements at hospitals, nursing and rehabilitation centers, blood banks and community health care centers Interns have the support of more than eighty health care professionals (including doctors, dentists, nurses, technicians) as workshop presenters and mentors The Hispanic Pre-Nursing Program exposes high school students to the nursing profession Student interns are placed in medical/health facilities under the direction of a nursing professional mentor Weekly didactic sessions engage students in hands-on research assignments related to health issues in traditionally underserved communities, and provide them with presentations by a wide range of health professionals This includes a Nursing Club that exposes students to various careers within the field of nursing Students meet weekly and participate in workshops on the academic and professional preparation required for nursing and other health care careers The program also includes hospital tours and tours of health science facilities and introductions to individuals who are active in the clinical and public health nursing fields Students attend health exhibits, college preparatory sessions and participate in community service projects and job shadowing Health Career Workshops, Outreach and Presentations are offered to schools throughout Brooklyn Queens and Long Island The program provides speakers for career day at various high schools, participates in career fairs and conferences and organizes an annual health career conference The Medical Academy of Science and Health Camp (MASH) offers junior high school students the opportunity to spend one day in the world of hospital health care during the academic year The goal of MASH is to provide a fun learning experience for youth and to promote health professions as a career choice
