Crude Accountability works with the community of Berezovka in western Kazakhstan, where the Karachaganak Oil and Gas Condensate Field is located. We conduct environmental monitoring, environmental education and public awareness campaigns in this area. We also monitor environmental standards at the Tengiz Field and other oil and gas related sites in western Kazakhstan, including facilities associate with the Kashagan Field.

Crude Accountability works with environmental and social activists in Krasnodar region of Russia, including on the Taman Peninsula, where the Russkiy Mir Oil Terminal is located.
