NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The summary of significant accounting policies of Harvesters Reaching the Nations, Inc. ("Organization") is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Organization's management, who is responsible for the fairness and objectivity embodied in the financial statements. These accounting policies conform to generally accepted accounting principles and have been consistently applied in the preparation of the financial statements.

Organization

Harvesters Reaching the Nations, Inc. is a not-for-profit corporation that provides spiritual, economic, social and physical relief to those in need. The Organization's primary operations consist of an orphanage, school, and hospital located in Yei and Terakeka, The Republic of South Sudan, Africa.

Estimates

Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and reported revenues and expenses. Significant estimates used in preparing these financial statements include those assumed in recording the functional allocation of expenses, depreciation, and amortization. Actual results could differ from those estimates.

Financial Statement Presentation

Net assets and revenues, expenses, gains, and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, net assets and changes therein are classified as follows:

Unrestricted Net Assets- Net assets not subject to donor-imposed stipulations.

Temporarily Restricted Net Assets- Net assets subject to donor-imposed stipulations that may or will be met by actions of the Organization and/or the passage of time.

Revenues are reported as increases in unrestricted net assets unless use of the related assets is limited by donor-imposed restrictions. Expenses are reported as decreases in unrestricted net assets. Expirations of temporarily restricted net assets (i.e., the donor-stipulated purpose has been fulfilled and/or the stipulated time period has elapsed) are reported as reclassifications between the applicable classes of net assets. Contributions are recognized as revenues in the period unconditional promises to give are received. Contributions of assets other than cash are recorded at their estimated fair value.

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Cash and Cash Equivalents

The Organization considers all short-term investments with original maturities of ninety days or less to be cash equivalents. Cash equivalents totaled \$8,407 at December 31, 2012. The Organization places cash and cash equivalents, which, at times, may exceed federally-insured limits, with high-credit quality financial institutions. The Organization has not experienced any losses on such assets.

Inventory

Inventories consist primarily of medical supplies and are stated at lower of cost or fair market value. Cost is determined using the first in, first out method.

Property, Equipment, Depreciation and Amortization

Property and equipment are stated at cost or fair market value at the date the equipment is donated or purchased less accumulated depreciation and amortization. Major expenditures and those that substantially increase useful lives are capitalized. Maintenance, repairs, and replacements, which do not improve or extend the lives of the respective assets, are charged to operations when incurred. When property and equipment is sold or otherwise disposed of, the asset and related accumulated depreciation is removed, and any gain or loss is included in operations. Depreciation has been computed using the straight-line method over the useful life of the asset. Estimated useful lives as of December 31, 2012 are as follows:

Income Taxes

The Organization is exempt from federal income taxes under Section 501(a) of the Internal Revenue Code (IRC) of 1986, as amended, as an organization described in Section 501(c)(3) of the IRC. The Organization has been classified as an organization that is not a private foundations under IRC Section 509(a)(2), and as such, contributions to the Organization qualify for deductions as charitable contributions. However, income generated from activities unrelated to the Organization's exempt purpose is subject to tax under IRC Section 511.

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Accounting for Uncertainty in Income Taxes

Management has concluded that any tax positions that would not meet the more-likely-than-not criterion of Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) Topic 740-10, *Accounting for Income Taxes*, would be immaterial to the financial statements taken as a whole. Accordingly, the accompanying financial statements do not include any provision for uncertain tax positions, and no related interest or penalties have been recorded in the statement of activities or accrued in the statement of financial position. Federal and state tax returns of the entity are generally open to examination by the relevant taxing authorities for a period of three years from the date the returns are filed.

Donated Services

Contributions of services are recognized if the services received created or enhance non-financial assets or require specialized skills, are provided by individuals possessing those skills, and would typically need to be purchased if not provided by donation.

Expense Allocation

The costs of providing the various programs and other activities have been summarized on a functional basis in the statement of functional expense. Accordingly, certain costs have been allocated among the program and supporting services benefited.

Date of Management's Review

Subsequent events have been evaluated for potential recognition or disclosure through August 14, 2013, which is the date the financial statements were available to be issued.

NOTE 4: FOREIGN OPERATIONS

The Organization's school, orphanage, and hospital is located in The Republic of South Sudan, Africa. Program expenses are incurred primarily using the local currency and converted to U.S. dollars using the prevailing market exchange rate for the month in which the expenses are incurred. The cost of long-term assets, also purchased using local currency, is recorded using the exchange rate in effect during the month the assets are purchased or constructed. The land on which the school and orphanage is located is owned by the Evangelical Presbyterian Church of Sudan. The church does not charge the Organization rent for the use of the land. No in-kind contribution or expense has been recognized in the accompanying financial statements for the use of the land due to the lack of a readily determinable market value.

NOTE 5: FUNDRAISING EXPENSES

The Organization typically receives an annual grant from a community foundation (totaling \$103,000 for 2012) which is restricted for fundraising expenses. The expenses paid for by this grant are approximately 64% of fundraising costs and are included in total fundraising expenses of \$162,949. The remaining fundraising expenses of \$59,949 are paid for by the operating budget and total only 6% of total expenses for 2012.
