UNDER ITS PREVENTION EDUCATION PROGRAM COMPONENT, ERC PROVIDES LIFE COACHING AND SKILL BUILDING PROGRAMS AND COMMUNITY OUTREACH SERVICES ACROSS SIX PUBLIC HEALTH DISTRICTS IN GEORGIA. DURING 2012, ERC CONDUCTED 20 HIV AND SEXUALLY TRANSMITTED INFECTION (STI) AND TEENAGE PREGNANCY PREVENTION PROGRAMS AND WORKSHOPS FOR MEDICALLY AND ECONOMICALLY DISADVANTAGED CLIENTS WITH HIGH-RISK BEHAVIORS. ERC HAS SEVERAL PROGRAMS, SUCH AS VOICES, AND SIHLE(SISTERS INFORMING, HEALING, LIVING, AND EMPOWERING). A TOTAL OF 150 UNDUPLICATED PARTICIPANTS ATTENDED THESE SESSIONS AND 570 SAFER SEX KITS WERE DIRECTLY DISTRIBUTED AT HOMELESS SHELTERS, TRANSITIONAL HOUSING PROGRAMS, MENTAL HEALTH AND SUBSTANCE ABUSE OUTPATIENT FACILITIES, JOB READINESS PROGRAMS, CORRECTIONAL FACILITIES, FOSTER HOMES, ALTERNATIVE SCHOOLS, RECREATIONAL CENTERS, AND HEALTH FAIRS. ERC ALSO OFFERS CAPACITY BUILDING PROGRAMS THAT PROVIDE PROFESSIONAL DEVELOPMENT AND TRAINING OPPORTUNITIES, EXPAND COMMUNITY RESOURCES, AND ESTABLISH SOLID FOUNDATIONS FROM WHICH TO ADDRESS HEALTH RELATED DISPARITIES FOR STAFF, VOLUNTEERS, AND OTHER NON-PROFIT ORGANIZATIONS. ERC CONDUCTED FOUR (4) CAPACITY BUILDING SESSIONS WHICH COVERED HIV BASICS, RAPID HIV TESTING, THE SCIENCE OF HIV TOPICS, AND PEER EDUCATOR WORKSHOPS, WHICH ASSIST PEOPLE LIVING WITH HIV AND AIDS TO BECOME EFFECTIVE PEER HEALTH EDUCATORS.
