THE EMERGENCY SHELTER PROVIDES TEMPORARY RESIDENTIAL CARE AND SPECIALIZED SERVICES TO THIRTY-FOUR CHILDREN AND TEENS (GIRLS AGES BIRTH - 18 YEARS & BOYS AGES BIRTH - 11 YEARS) AT ANY GIVEN TIME.
