THE TARGET POPULATION SERVED BY ACTS IS THE DISABLED, ELDERLY, AND WORKING POOR WITH INCOMES NOT MORE THAN 150% OF THE FEDERAL POVERTY GUIDELINES. THE AVERAGE COMBINED MONTHLY INCOME IS ABOUT \$925/MO. IN 2012 ACTS INTERVIEWED 3,722 CLIENTS TO ESTABLISH NEED, INCOME AND FREQUENCY WITHIN SERVICE GUIDELINES.
