It is designed to meet all the mission elements of the Center for an Agricultural Economy, to be a food-business incubator by providing the infrastructure necessary to do so, to provide education and technical assistance, and to provide hunger relief through food processing and storage.

Food System Access and Education the purpose of this program is to raise awareness of our local food system, to relieve the incidence of hunger through local food access, and to create collaborative partnerships to enhance the community's understanding of food and farming. The program includes our Food Access Fund work with the Greater Hardwick Food pantry, being a local resource for schools who are designing curriculum and integrated hands-on work for students, our management of the Hardwick Community Gardens, our Community Processing days and our public events which center on agriculture and working landscapes
