These direct service funds went to the needy in Columbus, West Point and LaGrange, Georgia and Phenix City and Seale, Alabama.

We continued to fund the development of the Youth Leadership Project (INFUSION) which engages 15 high school students in various activities in social ministries, various religious reflections and studies, and hands on servant leadership in the community. We continued a reading program in the Beallwood Area of Columbus, Georgia, and supported a community garden in the Beallwood Area. We also promoted and attended diocese educational programs to engage our communities in the possibility of developing programs like INFUSION.

4c (Code:) (Expenses \$ 12,609 including grants of \$) (Revenue \$ 4,165)

TAP - (Thompson-Pound Arts Program) - We sponsored TAP in Columbus, Georgia, and promoted it in LaGrange, Georgia, planning for the next year's program there. TAP is an annual multicultural and interfaith arts summer camp for approximately 175 children and teen mentors which teaches tolerance through various arts.
