Annual meeting of membership - papers presented and speakers on current topics. Representing 67 of the nation's universities, the NAUFRP has focused recent efforts on a number of emerging topics. It has worked with public and private sector partners to identify and prioritize a national research agenda, and formed alliances with other non-governmental organizations on a range of issues including natural resource sustainability, renewable energy, and climate change. This year's key focus was given to meeting with partners to learn what their future priorities for forestry research are. These were then used to determine, through break-out work sessions, how NAUFRP can better align its research priorities with them. In 2012, planning began for the 2014 International Union of Forestry Research Organizations to be held in 2014 in Salt Lake City.
