Facilitated 51 church groups involving 807 people from Lower 48 to come to Alaska to serve. Our expenses included housing, volunteer staff, hosting, airport transfers, meals, transportation, and all ministry set up. These teams worked in Anchorage, Wasilla, remote Native villages, and also towns on the road system. Most of the work was with disadvantaged children and youth - feeding a thousand meals a week to kids, conducting religious and recreation programs in local parks, sponsored week camp for 46 children/youth from disadvantaged homes. Program expenses also include all team expenses, all vehicle expenses, mission aviation, housing expenses, GraceWorks Grandview Baptist, and 90% of Scott Kirby salary package. Revenue includes funds from participants, gifts for mission aviation, contributions for missionary Scott Kirby, and designated gifts for carrying on the Alaska work - including gifts to buy food for the children in parks.

Facilitated one volunteer mission team to Romania in November involving 25 people. Expenses included plane tickets, insurance, overseas ground costs (food/housing/land transport). Also included here 10% of Scott Kirby salary package. Scott organized and led this team.
