The Bicycle Recycling Program (BRP) refurbished and donated 143 child and adult bikes. A helmet was also donated with every bike. For adult bikes (74), a set of lights and locks were also donated with each bike.

4b (Code:) (Expenses \$ 10,164.81 including grants of \$ 144.77) (Revenue \$ 144.77)
The corporation worked with Athens-Clarke County government to create a strong Complete Streets Policy that will require new road designs consider the needs of all users: drivers, cyclists, and pedestrians. The corporation also worked with the Athens-Clarke County Municipal Court to provide monthly bicycle safety training to DUI violators. The corporation also began speaking at local schools about the importance of helmet use.

Every third Saturday, April-November, the Corporation hosts an information table at the local Athens Farmer's Market. Additionally, the first Friday of every month, February-December, the Corporation hosts a local group ride around downtown. The corporation hosts numerous other social events throughout the year to raise awareness for biking and walking.
