2012 has been a blessed year for KCM and the Kingdom ministries here.

We hosted the 19th All India Christian Convention at Kochi in January.

Over 1000 people attended the convention from all over India.

Wendy and Keri Duncan from Mt. Carmel Christian church, Stone Mountain GA. spent a week with KCM leading the Children's sessions at the convention and training our Sunday school teachers.

Randy Snyder from Cross View Christian Church, Dayton, Ohio, and John Caldwell, President. ICOM- Indianapolis 2012 were speakers at 19th AICC.

The Seminary of the Nations sent Dr. John Turner to teach our preachers (56) in February on the "Leadership principles of Nehemiah."

In March Scott Moore and Steve Miller from Eastridge Community Church, conducted a class on "Purpose Driven Church" and it was very useful.

Martin Joseph, Cindy Martin and A. Johnson conducted seminars and youth programs in Andhra in the month of April.

We have planted two more churches in Andhra Pradesh this year and the total number there is ten at present. (This is the Mission project of the churches in Kerala.)

6 young men from Odisha (Formerly Orissa) were trained at Kottayam, Kerala and sent back to their home state to preach and start congregations.

Now they are ministering in six villages in Odisha meeting in their homes and breaking bread each Lord's day.

In 2012 our ministry has expanded to 6 more villages in the State of Odisha.

Vacation Bible Schools were conducted in most of the Kerala churches. (37) 27 Kerala Churches are self supported now.

A new syllabus for the Sunday schools was completed and is used in all our Sunday Schools.

We have started the building project for Carmel Girls home and Shalem Old age home. When completed this facility will accommodate 120 people.

Cindy has started Bible classes for the women in Kottayam area.

The youth ministries are growing and the annual youth talent meet at Kottayam on August 31 had 200 participants selected from 37 Kerala Churches.
