A yacht or tender donated to SeaKeepers is immediately delivered to a chartering agent. A percentage of charter revenue is paid to SeaKeepers over three years, with a purchasing option after the term is over.

While vessels donated to SeaKeepers are suitable for scientific projects, the cost of keeping all donated vessels is too great to manage. Accordingly, the chartering program eases this burden and facilitates SeaKeepers' mission to preserve the world's oceans and offering research platforms to the scientific community.

4b (Code:) (Expenses \$ 305 including grants of \$) (Revenue \$ 0)**Scientific Vessel of Opportunity Program**

Unites science and the broader yachting community by forming partnerships between research scientists and participating members. The program provides scientists with the necessary platform on which to conduct cutting-edge research by placing them on member vessels. Likewise, members have the exceptional chance to meet with scientists of interest and involve themselves directly in ocean data collection and preservation. All types of projects, from deep-sea exploration to water quality monitoring, are considered.

4c (Code:) (Expenses \$ 135,733.12 including grants of \$) (Revenue \$ 306,240.90)**Special Events**

Fundraising events held throughout the year serve to consolidate our membership base, attract corporate sponsorships to the environmental cause, and create publicity for our mission that permeates the yachting industry.

For this purpose, our events were held during important events for the industry, such as Art Basel, the Miami, Palm Beach, and Fort Lauderdale Yacht Shows, and the America's Cup in Newport, Rhode Island. The Bal de la Mer, held in Monaco, has been proprietary to the SeaKeepers name since 1998, as it is the venue for the SeaKeeper Award, presented to distinguished contributors to the mission to preserve our oceans.
