Employment Enhancement Opportunities Program provided paid employment training & placement services to 28 women in our local domestic violence shelter and 45 community re-entry workers recently out of prison, drug/alcohol rehab needing transitional employment while preparing for community employment integration. Retail sales/POS systems, computer publishing, barista, library science are just a few of the employment training opportunities this program offers. Of those 73 people, 38 secured employment, 29 are still in the paid training program (2013 carry over) and 6 relocated out of the area and we have no information. Another 162 people came in for job placement assistance for resume prep, help filling out applications, interview clothes, opening and using email accounts etc

Not-For-Profit Multi-Tenant Resource/Community Center 2012 Stats - 36 - 12 Step Self-Help meetings per week (631 people per week). 22 meeting/training events for other community based service organizations per week. Center is utilized by community based Not-For-Profits, civic groups and other service organizations an average of 19 hours per day, 7 days per week. Recovery & self-help library and bookstore provided over 4200 recovery based medallions, books, workbooks, tools to help people on their path toward healing and sobriety. Approximately 27 people per day came into the center to access the " wall of community resources", for brochures, applications and information on local community resources available to help.
