BROWARD COUNTY TO WEST PALM BEACH AND RECEIVE TRANSPORTATION FROM THEIR ELEMENTARY, MIDDLE OR HIGH SCHOOLS TO THE Y TO PARTICIPATE IN THE PROGRAM IN 2012, NEARLY 70 YOUTH, TEENS AND YOUNG ADULTS WITH DISABILITIES PARTICIPATED IN SPECIAL NEEDS PROGRAMMING AT THE Y CARIDAD KIDS SUMMER CAMPTHE Y PROVIDES SUMMER CAMP FOR CHILDREN OF ITS LOCAL COMMUNITY TO PROMOTE HEALTH, EDUCATION AND CONTINUED DEVELOPMENT IN THE MONTHS SCHOOL IS NOT IN SESSION CHILDREN NOT PARTICIPATING IN A SIMILAR PROGRAM HAVE BEEN FOUND TO RETURN TO SCHOOL BEHIND IN THEIR EDUCATIONAL SKILLS EXPERTS HAVE REFERRED TO THIS AS AN EDUCATION GAP, DISCOVERED TO BE MORE PREVALENT AMONG LOW-INCOME CHILDREN SINCE 2005, THE Y HAS BEEN PROVIDING A SOLUTION TO THE NEED FOR SUMMER PROGRAMS FOR CHILDREN FROM CARIDAD CLINIC AND THE MIGRANT ASSOCIATION THE ORGANIZATIONS ARE EXCITED TO HAVE A PARTNERSHIP WITH THE Y TO PROVIDE SUMMER CAMP FOR AGENCY CHILDREN SIXTY-NINE CHILDREN WERE ENROLLED IN THE YMCAS SUMMER CAMP PROGRAMS IN 2012 THESE CHILDREN WERE OFFERED FULL FINANCIAL ASSISTANCE TO ATTEND CAMP FOR THE ENTIRE 10 WEEKS OF SUMMER BREAK WITHOUT THE PROGRAM, MANY OF THE CHILDREN WOULD BE AT HOME UNSUPERVISED OR IN A FIELD ALL DAY WHILE PARENTS WORK FAMILY LITERACY PROGRAMTHE FAMILY LITERACY PROGRAM ADDRESSES THE NEED FOR PARENTS IN A FAMILY TO COMMUNICATE IN ENGLISH FOR THE SAFETY, EDUCATION AND GENERAL WELL-BEING OF THEIR FAMILIES THE PARTICIPANTS CAN COMMUNICATION TO MEDICAL PROFESSIONS, TEACHERS AND OTHERS AS A PARENT, RATHER THAN THROUGH AN OLDER CHILD THEY CAN UNDERSTAND AND ASSIST WITH THEIR CHILDRENS SCHOOL WORK PARTICIPANTS CAN ALSO SEEK JOBS OR HIGHER EDUCATION, THEMSELVES IN ADDITION, AS THE PARENT IS LEARNING, SO ARE THE CHILDREN, CONTRIBUTING TO THEIR EDUCATIONAL DEVELOPMENT THE PROGRAM STRIVES TO BREAK THE CYCLE OF LITERACY AND ULTIMATELY POVERTY OF THE FAMILIES IT SERVES ONE AREA OF CONCERN WAS THE REALIZATION OF SCHOOL AGE CHILDREN ACTING AS HEAD OF THE HOUSEHOLD TO COMMUNICATE FOR THE FAMILIES THEY MISS SCHOOL TO ATTEND DOCTORS APPOINTMENTS, ASSIST WITH JOB HUNTING OR OTHER FAMILY MATTERS THE PARENTS WANTED THE LITERACY SKILLS BUT DID NOT HAVE A RESOURCE FITTING THEIR SPECIFIC NEEDS THE PROGRAM MODEL FOCUSES ON FAMILIES WITH CHILDREN AGES 2-4 YEARS WITH A STAY-AT-HOME PARENT OR GUARDIAN (MOST FAMILIES ALSO HAVE OLDER CHILDREN) THE PROGRAM PROVIDES CLASSES TWICE A WEEK INCLUDING INTERACTIVE LITERACY, LITERACY CLASSES FOR ADULTS AND CHILDREN, HEALTHY SNACKS AND PHYSICAL ACTIVITY BY TEACHING LITERACY TO THE ADULTS AND BEGINNING COMMUNICATION AND LITERACY WITH THE PRE-SCHOOL AGE CHILDREN, THE PROGRAM BEGINS TO BREAK THE CYCLE OF ILLITERACY WITHIN THE FAMILY VOLUNTEERSTHE Y BELIEVES THAT IT HAS A ROLE IN STIMULATING VOLUNTEERISM, BUILDING CITIZEN LEADERS OF ALL AGES, AND PROVIDING THE OPPORTUNITIES FOR PEOPLE TO GIVE BACK ADDRESSES AN IMPORTANT SOCIETAL NEED AND TRANSFORMS OUR COUNTY INTO A WELCOMING COMMUNITY THE EFFORT NOT ONLY ENABLES THE Y TO ACCOMPLISH ITS MISSION, BUT WILL ALSO PROVIDE THE VOLUNTEERS WITH LIFE-CHANGING LEADERSHIP DEVELOPMENT OPPORTUNITIES THE Y IS COMMITTED TO TEACHING-BY WORD AND EXAMPLE- THAT THERE ARE MANY WAYS TO CONSIDER OTHERS BEFORE SELF AND TO DEVELOP ONES GIFTS, ENABLING INDIVIDUALS TO DO IMPORTANT THINGS FOR THEIR COMMUNITY TO THIS POINT, OVER 539 VOLUNTEERS HAVE PROVIDED SERVICES TO THE Y THROUGH INVOLVEMENT IN OUR THREE BOARDS, AS COACHES ON THE SPORTS FIELD AS WELL AS IN MANY OF OUR OTHER AREAS AS PROGRAM AND POLICY VOLUNTEERS
