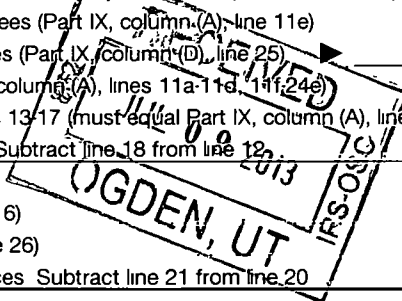

CLIENTS ARE SCREENED BY PHONE AND ONCE ELIGIBILITY IS DETERMINED, CLIENTS ARE SCHEDULED TO RECEIVE EMERGENCY FINANCIAL ASSISTANCE BY APPOINTMENT WITH OUR EMERGENCY SERVICES CASE WORKER.

2. EMERGENCY FOOD ASSISTANCE IS PROVIDED THROUGH OUR PEARLMAN PANTRY. FOOD CLIENTS ARE ELIGIBLE TO RECEIVE ASSISTANCE ONCE EVERY SIX MONTHS AND APPOINTMENTS ARE SCHEDULED BY PHONE TO RECEIVE FOOD ASSISTANCE. IN 2012, JFS PROVIDED FOOD FOR MORE THAN 77,000 MEALS TO INDIVIDUALS AND FAMILIES IN NEED.

THE CENTER FOR COUNSELING, GROWTH AND DEVELOPMENT ENCOMPASSES INDIVIDUAL, COUPLE, FAMILY AND GROUP MENTAL HEALTH COUNSELING SERVICES. ALL COUNSELORS AT THE CENTER FOR COUNSELING, GROWTH AND DEVELOPMENT HAVE MASTER'S DEGREES AND ARE LICENSED OR WORKING TOWARDS LICENSURE. IN 2012, JFS PROVIDED MORE THAN 1,400 MENTAL HEALTH COUNSELING SESSIONS SERVING OVER 200 CLIENTS. JFS IS ONE OF A FEW AGENCIES THAT OPERATE ON A SLIDING FEE SCALE TO MEET OUR CLIENTS' NEEDS DESPITE THEIR FINANCIAL MEANS.

THE ROTH FAMILY KIDSKONNECT PROGRAM IS AN EIGHT-WEEK PSYCHO-EDUCATIONAL SUPPORT GROUP FOR CHILDREN EXPERIENCING FAMILY DISRUPTION RESULTING FROM DIVORCE, DEATH, ABANDONMENT, INCARCERATION, HOMELESSNESS, MILITARY DEPLOYMENT, OR OTHER UNIQUE FAMILY SITUATIONS. MASTERS LEVEL MENTAL HEALTH PROFESSIONALS FACILITATE THE KIDSKONNECT GROUPS AT SELECT ORANGE AND SEMINOLE COUNTY SCHOOLS AT NO COST TO PARTICIPANTS. IN 2012, 23 ELEMENTARY AND MIDDLE SCHOOLS PARTICIPATED IN THE PROGRAM, SERVING A TOTAL OF 420 STUDENTS. SINCE ITS INCEPTION IN 2000, OVER 7,400 CHILDREN HAVE BENEFITTED FROM THE ROTH FAMILY KIDSKONNECT PROGRAM.
