Immigration and social services are also provided to the underprivileged. Training is provided to promote self-esteem, Business skills, and education. Financial and health programs, and educational scholarships are also provided. The organization focuses its assistance on farmworkers and other rural poor. Farmworkers' Self-Help was founded in 1982 with a mission to educate and empower immigrant Mexican and Mexican-American migrant farmworkers, along with former farmworkers and other oppressed and poverty-entrapped groups in Southwest Florida. Through community organizing, the organization addresses discriminatory and oppressive policies, and practices that adversely affect its community, particularly women and youth. The organization offers a holistic combination of programs that facilitate self-development and promote social change. See also statement 9.
