Property Management: ACT managed five major preserves with public access, and several smaller conservation properties. ACT's land management includes forest and groundcover restoration, creating and maintaining public trails, prescribed fire, and exotics control. ACT benefitted from the use of many dozens of volunteers and County court-ordered Community Service workers, who provided significant additional staffing for these activities.

4b (Code:) (Expenses \$ **78,949** including grants of \$) (Revenue \$)
Acquisitions: ACT acquired an additional 705-acre conservation property in Alachua and Putnam Counties known as the Little Orange Creek Preserve. Cost of this purchase was \$1.9M, provided in part from the US Fish & Wildlife Service, as well as through the Alachua County Forever program. Also acquired concurrent with this purchase were the mineral rights to over 15,000 acres in Putnam County, which are also now held under conservation. In addition, ACT executed acquisition of an 8-mile rail corridor in Alachua and Union Counties which it intends to develop as a rail-trail, along with a 96 acre trailhead park on the Santa Fe River. Funding for this acquisition was provided primarily by the Florida Communities Trust program and a private foundation grant.

Education and Outreach: ACT conducted more than three dozen environmental education classes and a dozen public concerts. ACT's Prairie Creek Lodge hosted innumerable special events, many of which were conducted in partnership with other non-profits and government agencies, including a series of paint-outs supporting north central Florida's threatened prairies, an annual conservation stewardship recognition banquet, the First Annual Florida Crane & Nature Fest, and the traveling visual arts-environmental educational program titled Springs Eternal-Urban Aquifer. ACT also participated in many community-wide events and festivals, sent out bi-annual newsletters, updated and maintained a comprehensive website, and had an increasingly active presence in social media.

Most monitoring of conservation easements is performed by ACT board members, who are also trained volunteers. During 2012, the restricted funds for Prairie Creek Preserve and Tuscawilla Preserve were invested with the Gainesville Community Foundation. Only Tuscawilla Preserve includes a conservation easement. The monitoring and enforcement endowments for all other conservation easements were invested with Florida Capital Bank. Only the interest in these endowments can be used for monitoring and the principal may be used for enforcement. The financial statements include the following footnote related to conservation easements: "Property owners grant to the Corporation conservation easements that restrict the owner's use of the land in perpetuity. Some allow the Corporation to conduct research and studies on the properties. Since the Corporation does not receive any rights to the property, the Corporation
