The Princeton Closet either sells donated clothing and household goods or donates these items to other organizations for the needy. In 2012, \$115,000 of these receipts were donated to area charitable organizations, other 501(c)(3) organizations, church related organizations and government sponsored programs. Donated clothing, household items and toys are also given at no cost to families and individuals who have suffered from a disaster such as a fire. These people are usually referred to us from local government agencies, American Red Cross and churches. In 2012, 368 vouchers were fulfilled to help individuals and families. Excess donated clothing, shoes and household items are either given to the needy or are eventually sent overseas and distributed to countries in need of clothing items, etc. The Princeton Closet has approximately 75 people who volunteer their time on a regular basis to assist in the Closet's mission. These people donated approximately 7,800 hours of their time to the closet in 2012. (CONTINUED ON SCHEDULE O)

They must apply by a written letter stating the amount of their funding needs and for what specific purpose (in any) the funds will be used for. The Church Women Executive Committee receives these letters, reviews and approves all funding allocations to organizations. The final list is presented at the Church Women United annual meeting held in January. The recipient organizations use of the funds are not normally monitored during the year. Most organizations apply for funding annually and it is at this time the Executive Committee may review the organizations previous years use of the funds received, ask questions and make adjustments to the amount of the current years allocation.
