Orphan Voice is a Christian orphan-relief organization that provides spiritual, physical and emotional support to Central Vietnams impoverished orphans, at-risk and special-needs children.

Orphan Voice provides total daily care (nutritional, educational, emotional, physical) to 21 children and provides half the food for an additional 32 children each month. Additionally, Orphan Voice has quarterly and semi-annually outreach projects to 2500 other children in orphanages. These periodic projects include: supplemental food delivery, purchase of clothes and new shoes, facility renovation, water and bathroom renovation and improvements. In addition to the tangible needs, Orphan Voice ministers to the spiritual, social and emotional needs of children through various outreaches and activities.

4b (Code _____) (Expenses \$ 38,420 including grants of \$ _____) (Revenue \$ _____)
Orphan Voice operates a therapy center that serves 78 special needs children, many with cerebral palsy, and their families. Prior to the opening of the therapy center, the children did not receive services - all being from the very poorest families from a poor region in Vietnam. The facility is open 198 hours per month and is staffed by three therapists plus administrators and support staff. In addition, Orphan Voice delivers 1,386 pounds of rice and 1,890 noodle meals to destitute families each month. Further, many of the children receive additional medical services for problems associated with thier special need.

4c (Code _____) (Expenses \$ 30,305 including grants of \$ _____) (Revenue \$ _____)
Orphan Voice works to protect vulnerable children from sexual predators in a region that is fast growing in international tourism. We do so in three ways. We operate Victory House, a home where all the needs of several girls who have aged out of orphanages are met while they attend college. Hope House is our effort to provide care for children who have actually been trafficked and are now recovering. Finally, Orphan Voice conducts anti-trafficking seminars in junior-high schools in poor areas to warn children about the dangers of child traffickers.
