THE STUDENTS ARE REFERRED THROUGH THE PRINCIPALS AND GUIDANCE COUNSELORS OF THE SCHOOLS SERVED. THESE ARE CHILDREN WHO ARE STRUGGLING EITHER SOCIALLY OR ACADEMICALLY & NEED EXTRA SUPPORT. PROGRAM DIRECTOR MAKES SCHOOL VISITS TO MONITOR THE PARTICIPANT'S PROGRESS. DURING THE SUMMER, THE CHILDREN ATTEND AN 8 WEEK ACADEMIC-BASED PROGRAM. 2012 REPORT CARD PERCENTAGES SHOW STUDENTS SCORING AVERAGE OR ABOVE IN EACH OF THE SUBJECT AREAS: MATHEMATICS-88%, READING-78%, LANGUAGE ARTS-96%, SOCIAL STUDIES-97%, AND SCIENCE-97%. 95% ALSO HAVE POSITIVE MARKS IN CONDUCT.
