Middle Tennessee Scholastic Art Competition

The Tennessee Credit Union is the sole financial sponsor for the Middle Tennessee Scholastic Art Competition held annually at Cheekwood Art and Gardens. In 2012, The Tennessee Credit Union contributed \$10,000 in funds to finance the competition and make entry fees affordable for all young competitors in the Middle Tennessee area.

PENCIL Foundation

Each year, The Tennessee Credit Union participates in the PENCIL Foundation Program that partners businesses with public schools in Davidson County. In 2012, TTCU donated \$2,000 to the Foundation among other donations to our partner school since 1989, Wright Middle School.

COMPASS

The Tennessee Credit Union participates in the COMPASS Program that partners businesses with public schools in Sumner County. TTCU donated \$6,523 to COMPASS (Via Ebsco Professional Partnership Group) in 2012 and various donations of \$2,000 cash and items for the partner school's (Gallatin High School).

Antioch High School

During 2010, The Tennessee Credit Union entered into a 5 year commitment to Metro Nashville Board of Education to establish, provide equipment, furnishings, educational training, and operational support for the Antioch High School's "The Tennessee Credit Union Academy of Business and Finance". Additionally, TTCU provides paid summer internships to worthy students, training them in operating a limited service Credit Union at the school. During 2012 TTUC provided \$69,386 in resources such as internships, training, and equipment for the program.

Other Education and Credit Union Causes

The Tennessee Credit Union provided funding to many educational, civic, charitable and credit union causes in 2012. \$2,000 donations were made to the Tennessee Association of School and Business Officials for their annual conference. \$1,000 was provided to the McDonough Scholarship administered by the Metro Nashville Retired Teachers Association. \$1,000 donations were made to scholarship funds administered by Putnam County Retired Teachers Association. The Tennessee Credit Union granted at least \$7,000 of scholarships to students to all of the geographic area they serve.
