PART IV, Line 11(b): The form 990 was reviewed during a special meeting by all members of the board.

PART IV, Line 12(c): The company meets quarterly to discuss various ongoing issues with the organization including the conflict of interest policy. Member were informed that they had an ethical and legal duty to disclose any conflicts of interest as they arose in the normal course of business.

PART VI, Line 15(b): The 2012 salary of the President and CEO was \$10,000 which is substantially lower than commensurate leaders earn. This is the first year the President & CEO has taken a salary. As the finances of the organization have improved a salary was warranted at this time.
