In 2012, Amistad Mission provided life-changing medical, educational, spiritual and emotional care to more than 90 children, youth and young adults in Villa Amistad in Cochabamba, Bolivia and more than 50 impoverished Quechua families in the rural village of Aramasi. Through exceptional care and a Christian family environment, the children at Villa Amistad grow up in one of eight homes with their biological siblings. In 2012, Amistad provided support to children from as young as a few months up to university students in their mid-twenties. Over 90% of Amistad's college-age young adults are either attending university or technical school, a significant accomplishment in a country where less than 10% of the population has a professional degree.
