

UNDER A GRANT ADMINISTERED BY THE COMMUNITY SERVICES PROGRAMS OF WEST ALABAMA, CASE MANAGERS WERE HIRED TO HANDLE THE INDIVIDUAL CASES OF NEED. THESE CASES ARE PRESENTED TO THE LTRC. INCLUDED IN THE CASE PRESENTATION ARE ASSESSMENTS OF DAMAGES. IF THE CASES ARE APPROVED FOR FUNDING BY THE LTRC, THEY ARE THEN BID OUT TO CONTRACTORS. THOSE BIDS ARE REVIEWED AND THE CASE IS AWARDED TO THE CONTRACTOR. UPON COMPLETION, THE CONTRACTOR PRESENTS AN INVOICE FOR SERVICES RENDERED TO THE CHAIR OF THE FINANCE COMMITTEE ON THE LTRC. THE FINANCE CHAIR PRESENTS THE CFWA WITH AN AUTHORIZATION FOR DISBURSEMENT ALONG WITH THE INVOICE AND OTHER PAPERWORK. THE CFWA ISSUES A CHECK REQUIRING TWO SIGNATURES.

ALTHOUGH THERE HAVE BEEN SMALLER CONTRIBUTIONS TO THIS FUND, THERE HAVE BEEN SIX MAJOR CONTRIBUTORS TO THE LTRC ACCOUNT. EACH HAD DIFFERENT STIPULATIONS ON HOW THE FUNDS WERE TO BE SPENT AND ACCOUNTABILITY RECORDS WERE FILED.

THE LTRC PLANS TO CLOSE THE FUNDING PROCESS BY YEAR END OF 2013. ANY RESIDUAL FUNDS WILL BE DISBURSED AS PRESCRIBED BY THE ORIGINAL GRANTORS OR RETURNED TO THE ORIGINAL GRANTORS.
