**28** The Eagles Wings Foundation (EWF) has entered into a formal partnership with the Bahamas National Emergency Management Agency (NEMA) This partnership has increased the capacity of EWF in the Caribbean by creating a formalized process for response requests to be channeled The partnership has also increased the volume of dialogue between EWF and NEMA, allowing for Best Practices to be shared on both sides of the agreement EWF has also participated in planning for the USCG Operation Black Swan Mass Rescue Full Scale Exercise (called the most complex and largest exercise in maritime history by the USCG), which will occur in Freeport, Bahamas in 2013

**29** The Eagles Wings Foundation (EWF) deployed to western Palm Beach County in response to the flood event that occurred as a result of Tropical Storm Isaac EWF assisted in providing Palm Beach County with the Pathfinder Rapid Assessment Software (PRAS) First responders used PRAS to document floodwater incursion into residential neighborhoods, as well as documenting contact with affected citizens Outreach missions such as bottled-water-distribution were also documented with PRAS Because of this service while assisting under a large fire department, Eagles Wings ties into the fire service have grown significantly, which has helped in recruiting future, professional volunteer responders for deployments in areas of need
