In 2012, AVEH engaged in several fundraisers with the goal of raising \$100,000 in order to meet a matching pledge. At the end of 2011, AVEH received a pledge of \$100,000, half of which was granted immediately, the other half to be provided once the full \$100,000 is matched by other donations. Five fundraising campaigns were conducted in 2012, raising a total of approximately \$63,000. In addition, AVEH received a \$15,000 foundation grant. Moreover, with the completion of its mortgage refinancing in 2011, the rental income it receives equals the interest payments it makes, so it no longer had a negative cash flow. This meant that each dollar raised can go toward a fund to build a five-unit assisted living facility, rather than servicing mortgage loans. An account established for funds to pay for this construction has been established and at the end of 2012, it had a balance of about \$110,000.
