STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS

Activities in 2012 focused on three themes – oral health literacy, access to care issues, and education/mentoring. The group met with the Dental Trade Alliance Foundation and continues to assist the Foundation with allocating oral health scholars' grant funding requests. The group has been actively exploring oral health workforce issues and evaluating the programs that several states have implemented to address the issues. The SFG continues to assess how various initiatives affect the workforce issues and quality of access to care. The SFG and American Dental Hygiene Association partnered in 2012 to plan for a 2013 symposium. The event will bring together stakeholders to explore the hygiene profession's curricula and role in meeting the oral health needs of today.
