In 1995, Earth Mission helped open the Gilgit Eye Hospital with the express purpose of providing quality eye care to people in the remote, Gilgit-Baltistan area of Pakistan. The hospital employs local staff including a local ophthalmologist. Services include an outpatient clinic, a full optical workshop, a well stocked pharmacy and day surgery. Leadership for these works has been turned over to John Douglas, under Vision International. Earth Mission continues to partner with Gilgit Eye Hospital.

4b (Code _____) (Expenses \$ 11,000. including grants of \$ 11,000.) (Revenue \$ _____)

In 2002 Earth Mission opened the Gilgit Education and Rehabilitation Center. This program includes a boarding option and provides help for the physical, emotional and educational needs of blind children. Over the last few years the government has worked to begin providing education as well through a Special Needs School. GERC has come alongside during this time and helped train. They will now allow the government too provide these services.

GERC will continue to work with a community based program which offers help for a wider range of physically-limited children and their families in the Gilgit-Baltistan area.

4c (Code _____) (Expenses \$ 218,086. including grants of \$ 933.) (Revenue \$ _____)

In 2005 Earth Mission began working with internally displaced people of Burma. This effort has become focused on helping the Free Burma Rangers(FBR) provide quality medical care inside the conflict zones. In 2010 Earth Mission helped start a year long clinically based training program for beginning Karen medics (the Jungle School of Medicine - Kawthoolei). For experienced medics, Earth Mission helps FBR doctors, nurses and senior medics conduct regular month long review courses. When necessary, medics are able to transport stable patients to medical facilities beyond the conflict zones, to countries where high quality care is available. Earth Mission helps to fund and support these referrals. The first class of 20 medics graduated in January 2012. During 2012 Earth Mission built a 50 meter suspension bridge in Burma
