New Orleans Artist Against Hunger and Homelessness, Inc. (NOAAHH) applied and received tax exempt status in December 1998. NOAAHH filed all required tax returns and state filings from 1998 to 2004. On August 29, 2005, Hurricane Katrina caused devastating damage to the greater New Orleans area with extensive flooding that impacted 80 percent of the city. The storm affected all individuals involved with NOAAHH, including the Board of Directors and the CPA for the organization. Many board members were displaced due to loss of their homes. NOAAHH has no paid employees and relies solely on its all-volunteer Board of Directors.

The CPA for the organization prepared the tax returns and maintained all financial information for the organization. Tax returns were filed late after Hurricane Katrina due to the widespread damage after the storm. The Board understood the returns were being prepared and filed by the CPA and the Treasurer.

The Board sent several correspondences to the CPA requesting status of all tax returns, but did not receive a response. Upon investigation, the board discovered that the CPA for the organization suffered a nervous breakdown after the storm. As a result, the tax returns for the years 2008 and forward were not filed by the organization.

The Board of Directors was not aware of this until November 2013. At that time, the Board immediately hired a new CPA to prepare the delinquent tax returns. The new CPA discovered that the tax exempt status for NOAAHH had been revoked in May 2011 due to the non-filing of returns for three years.

Despite numerous attempts by the Board, NOAAHH was unable to obtain records from the former CPA for the years 2008 to 2012. Records had to be ordered from the bank and reconstructed for those years. For the past four months, the information for the delinquent years has been compiled by the new CPA.

Tax returns have been completed as of April 2014 and submitted to the IRS for 2008, 2009, 2010, 2011, and 2012. The 2013 tax return will be filed in the next 30 days and an extension was requested.

NOAAHH respectfully requests that the tax exempt status of NOAAHH be reinstated and that the reinstatement be retroactive back to 2011 for the following reasons:

- 1) We relied on our CPA to file and submit the returns.
- 2) The destruction and devastation from Hurricane Katrina impacted NOAAHH, its Board of Directors, Officers, and the CPA.
- 3) All delinquent returns have been filed and all future returns will be filed on time.
