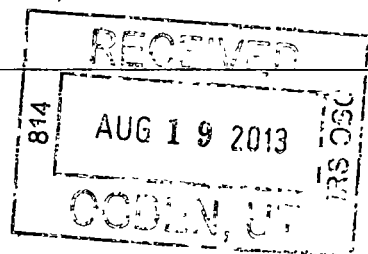

Pt III, Line 31 The Undriving Education Project continues to build community awareness of alternatives to driving carbon-producing single-occupancy cars, issuing more than 10,000 Underiver licenses since 2007. Licenses include licensee-chosen "un-dorsements" for walking, biking, telecommuting, skipping the trip, carpooling, etc. Undrivers share alternatives and success stories through the webpage and email list as well as displaying their license on their commuter bags. Local governments and trip reduction programs are inviting Undriving to help educate increasingly large populations of commuters, because surveys show that Undrivers honor their commitments to drive less.

Pt III, Line 31 Healthy Habits' mission is to improve the health of young adults moving out of homelessness and into healthy, prosperous lives. Healthy Habits is structured around a variety of presentations and conversations on healthful eating, exercise, disease prevention, and self-care facilitated by naturopathic doctor Jeff Metzger, and is dedicated to improving the lives of the youth residents and elders at the Labateyah center. To improve the quality of food available to the teens and elders, Healthy Habits has developed donation partnerships with the Ballard Farmers Market, PCC Natural Markets, Whole Foods, and others. The Eclectic Institute, Pharmax, Western Herbs, and Restorative Formulations have donated medical supplies as well. The program is building a garden, making healthy swaps like homemade salad dressing for pre-packaged, artificial packets,

and experimenting with more interactive presentations based on youth feedback.

Pt III, Line 31 Urban Sparks is deepening our commitment to sustainable, energetic civic engagement by planning a mixed-used building called Service House. Service House will include affordable, community-oriented housing for AmeriCorps members, offices of 6-10 nonprofits, and education and gathering spaces including an auditorium, art displays honoring service, meeting rooms, and a café. Work in 2012 included partnership development, conceptual design of key spaces, research and development of business models for ownership and management, and curriculum outlining.

Pt III, Line 31 The Community Greenways and Trails project, including University Greenways and Kirkland Greenways, promotes street design and transportation policies that make neighborhoods safer for walking and biking for everyday trips. Greenways and Trails project leaders meet with city departments of transportation to present recommendations built from community input and international best practices. They also organize educational conferences and site visits to other walk/bike friendly cities and coordinate neighborhood advocacy events that include motorists, walkers and bikers of all ages.
