We provide humanitarian community-based assistance for the needy and neglected, focusing on rural Nigeria. Our programs seek to help alleviate hunger, provide medical assistance, sponsor literacy training and education, and assist in community development. We seek to enable individuals and communities to find solutions in adverse conditions. Our humanitarian efforts are provided in the context of ethnic and religious tensions that sometimes erupt in violence.

We shipped a 40-foot container containing donated medical supplies, consisting of basic hospital equipment, surgical instruments, and consumable medical supplies. The contents are primarily intended for ill-supplied clinics in rural locations -- to provide basic health care for families and individuals in poor communities. The higher-tech equipment will be directed to regional hospitals. After distribution, we intend to use the empty container for storage of grains.

4b (Code:) (Expenses \$ 9,075 including grants of \$ 6,175) (Revenue \$)
We assisted several local educational efforts, including elementary education, teaching literacy to adults, AIDS education, as well as assisting poor and underprivileged students with tuition for secondary and local college education.

4c (Code:) (Expenses \$ 3,350 including grants of \$) (Revenue \$)
Our community development efforts included a seasonal harvest investment, in which grains are purchased at harvest time and stored until the following year. They were sold at cost during the period of scarcity (summer) to members of the local community. We also helped with a local mediation and peacemaking effort to resolve inter-tribal conflicts.
