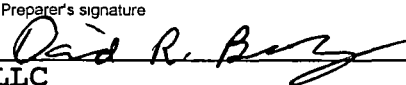

TWO CITY WIDE WOMEN'S SUPER SATURDAY CLINICS WERE CONDUCTED IN COLLABORATION WITH THE HEALTH ALLIANCE FOR THE UNINSURED. MORE THAN \$30,000 WORTH OF DONATED MEDICATIONS WERE DISTRIBUTED. OVER 4,200 TOTAL VOLUNTEER HOURS WERE GIVEN, 600 OF THOSE FROM PRIMARY CARE PROVIDERS. ASSISTANCE WAS ALSO PROVIDED IN ENROLLING ELIGIBLE PATIENTS IN PHARMACEUTICAL COMPANY PATIENT SUPPORT PROGRAMS.
