Bayou City Art Festival Memorial Park is held each year during the 4th weekend of March. Nestled in Houston's treasured Memorial Park, the festival is built on a loop surrounded by lush trees, foliage and picnic areas. The park is 5 miles from Downtown and 2 miles from the famous Galleria area. The festival is the only public event held in the park. Free, no-hassle shuttle rides from several locations make transportation to and from the festival easy and convenient. The festival features 300 juried local, national, and international artists with a paid attendance of over 25,000. Around \$120,000 in contributions were presented to our charity partners due to the success of the 2012 spring festival.

Bayou City Art Festival Downtown is held each year during the 2nd weekend of October and welcomes the changing colors of fall. The downtown skyline serves as a dramatic background for art, music, dance and interactive activities. The festival is showcased in Hermann Square, Sam Houston Park, Library Plaza & Tranquility Park. The festival features 300 juried local, national, and international artists with a paid attendance of over 20,000. Almost \$100,000 in contributions were presented to our charity partners even with foul weather compromising the 2012 fall festival.
