Rehabilitation of injured/sick sea turtles. Care and placement of non-releasable turtles. Healthy sea turtles are released back into the wild, non-releasable sea turtles are used for educational purposes. In 2012, 60 stranded sea turtles were recovered of these 41 were rehabilitated and released back into the wild. 2 non-releasable turtles were placed at the Wild World Aquarium in Phoenix, AZ.

Conservation - support of sea turtle conservation efforts worldwide. Sponsor of local (South Padre Island and Boca Chica) beach patrols and South Padre Island corral for protection of sea turtle nests and eggs. In 2012, 72 nests were found, 5594 hatchlings released, 13 public releases.

Education - educational presentations to school groups and the public to inform them of endangered status of sea turtles and how to support conservation efforts.
