#### Summary:

AVDA works to break the cycle of family violence through direct-services programs that protect and support victims, intervene with and rehabilitate abusers, foster a coordinated community response and educate youth to keep abuse from spreading to future generations

### Part III

4a. AVDA's Legal Advocacy Program is the primary source of free legal representation for low-income and working-poor victims of family violence in cases pending in the Harris County Family Courts. AVDA serves as attorney of record in lawsuits to safeguard victims from further abuse (protective orders, kickout orders, terminating the parental rights of child molesters) and to dissolve the legal ties that bind a victim to his/her abuser (divorce, Suits Affecting the Parent-Child Relationship). In 2012, AVDA's six attorney-paralegal teams litigated cases that directly impacted the safety, legal rights and financial stability of numerous victims

4b. AVDA's Battering Intervention & Prevention Program (BIPP) provided intervention services to largely referred to AVDA by court order. In AVDA's Teen Abuse Prevention Program, BIPP facilitators conducted group sessions, serving incarcerated youth

4c. AVDA's Family Violence Program provides safety planning, emergency resource referrals, and legal-system advocacy to all victims of family violence, regardless of income. In 2012, AVDA's Family Violence Program staff helped support, stabilize and protect adults and minor children who had experienced family violence.
