Bridges of Hope Legal Project: provides civil legal representation and consultation to victim/survivors of domestic violence in cases of divorce/legal separation, child custody, child support and other civil matters as a result of domestic violence. This program also provides advocacy and support to victim/survivors whose perpetrators have been arrested and are going through the criminal justice system.

During 2012, 209 survivors received assistance through Alternative Horizon's legal project.

24/7/365 Advocacy Services: trained advocates and staff provide immediate and ongoing assistance, support, and advocacy to victim/survivors of domestic violence through a 24-hour hotline, office phone, and office walk-in. Additionally, bilingual and bicultural staff provides culturally appropriate outreach and direct services specific to Hispanic/Latino and Native American victim/survivors.

During 2012, 618 survivors called the hotline and/or office for assistance. Total hotline volunteers - 14.

Individual therapy and counseling is provided as needed or requested. The Alternative Horizons therapist is available on a weekly basis at the Volunteers of America Southwest Safehouse to provide counseling to residents.
