EMI initiated designs for an additional 62 projects in 2012 in 28 countries around the world. About 250 design professionals and over 50 interns donated their time and expertise to partner with EMI in providing designs for these projects. In June 2012, a team of 10 architects, engineers, and surveyors traveled to south eastern Gabon to update a master plan for Bongolo Hospital as well as design a new outpatient facility and to do a comprehensive review and re-design of the hospital's waste water system. Bongolo Hospital has been serving the poor in southwestern Gabon for over 30 years with quality healthcare in pediatrics, adult medicine, surgery, and eye surgery.

In October 2012, EMI organized a team to design an orphanage outside of Les Cayes, Haiti for God's Vision for Haiti - a small, faith based ministry run by Haitian nationals who are excited to be used by God to help those who have lost their parents. A team of 8 design professionals developed a plan for their campus to include homes, a school, dining hall, and a community center. The team also developed materials to be used in communicating the vision and in helping to raise funds for the construction of the campus.

In September 2012, a team of three engineers traveled to Sierra Leone on short notice to provide support to Living Water International that was facing a cholera outbreak crisis. LWI has been serving the people of Sierra Leone by installing and maintaining clean water supplies as well as providing training on proper hygiene techniques. The three engineers were able to provide the necessary expertise to rehabilitate contaminated wells and slow the spread of cholera.
