Establish community awareness. Short term objective is reaching members of the community that need free pregnancy testing, prenatal and parenting education along with material assistance. Also provided is direction towards the appropriate medical authorities. Long term objective is to strengthen and build healthy families in the community. DPC's measurable outreach includes the following: 5000 flyers and newsletters distributed, 50 public appearances, 80 print and radio ads, 1500 direct mailings.

4b (Code: 4(b)) (Expenses \$ 21,474 including grants of \$ 0) (Revenue \$ 0)
Pregnancy testing, guidance and education. Short term objective is to provide a secure environment for women and men in crisis. Long term objective is to promote positive life skills which will lead to a healthier and more productive life. DPC's measurable outreach includes: 92 pregnancy tests, 44 individuals were provided emotional support, 324 individuals participated in prenatal and/or parenting education, 100 individuals were given abstinence information. Not included in reported expenses for this program is over 600 volunteer hours. The estimated value of these volunteer hours to the program is over \$14,000.

Material assistance to mother and baby. Short objective is to provide material support. Long term objective is to promote healthy, stable and independent living. There were 225 recipients of material assistance in 2012. 70 items of maternity clothing, 440 items of baby clothes, 21 cans of formula, 500 diapers, 20 large baby items such as furniture and 30 miscellaneous baby items that are essential to maturity and development. Not included in the reported expenses of this program is the estimated value of \$15,000 of donated mother and baby care items collected and distributed during 2012 and the 525 hours of volunteer labor involved in operating this program. The estimated value of these volunteer hours is over \$7,500
