Statement of Activities 2012

During 2012, Homelands Research Group, Inc., continued management and production of "Food for 9 Billion," a multi-platform media project designed to educate the public and stimulate engagement on the challenge of feeding the world at a time of rapid social and environmental change. The project is a partnership with the Center for Investigative Reporting, Cornell University, American Public Media's Marketplace, PBS NewsHour, and PRI's The World. Achievements included the broadcast of ten radio stories on Marketplace and six TV stories on PBS NewsHour, as well as online articles, videos, slideshows, blog posts, interactive features, and tweets.

The organization received a grant of \$100,000 from the New Venture Fund, and two grants of \$5,000 each from Cornell University College of Agriculture and Life Sciences. All of these grants were to support the "Food for 9 Billion" project.

Homelands entered into fiscal sponsorship agreements during 2012 with two independent media projects: "Dead Seas" (a book by journalist Mort Rosenblum) and "Journey to Armenia" (a documentary film by photographer Nubar Alexanian). Homelands continued to serve as fiscal sponsor for "The Way of the Warbonnet" (a book in progress).

Homelands Research Group, Inc., held its annual board meeting by conference call on December 14, 2012, with six of the eight members attending. Andrew M. (Sandy) Tolan was elected president, Alan Weisman was elected vice president, and Cecilia V. Vaisman was elected secretary/treasurer. Priscilla Pierce Goldstein resigned as a board member prior to the meeting.

The organization continued to operate with no employees, paying an executive director, an office manager, and reporter/producers as independent contractors on a fee-for-service basis.

Homelands Research Group, Inc., remained an Arizona corporation in 2012 while operating primarily out of the Ithaca, NY, home of its part-time executive director.
