GRANT MONITORING	PART I, LINE 2-	Scholarships We provide scholarships to graduating seniors of IISD The students submit applications for our scholarships which are reviewed by a group of volunteers and donors After a thorough review process, we determine the candidate that best meets the qualifications and award to that student Once the student arrives at their University, the student must send us proof of enrollment, an invoice showing a balance due, and a schedule showing that they have registered for at least 12 hours of classes Once we verify this information, we send payment directly to the university to be used for tuition only TEACHER Grants Teachers and other IISD staff may apply for our grants through our online grant system They must explain what the grant is to be used for- innovative classroom project, workshop for teachers, etc Once they submit their request with a details budget, their grant goes through a thorough review process The Principal on their campus must first review the grant, then the Division Director, then the Asst Superintendent, followed by the Chair of our Programs Committee Once approved, we process a check and send it directly to the school that applied for the grant money approved, we process a check and send it directly to the school that applied for the grant money
