

THE MUSEUM COLLECTS ARTIFACTS AND ARCHIVAL MATERIALS THAT ARE SUITABLE FOR ITS EDUCATIONAL AND EXHIBIT PROGRAMS. BECAUSE OF THE EDUCATION COMMITMENT, ITS EXHIBITS STRESS HANDS-ON LEARNING THROUGH HANDS-ON DISPLAYS. THE MUSEUM FEATURES HUNDREDS OF HISTORICAL ARTIFACTS, PHOTOGRAPHS, FULL-SCALE AIRCRAFT ENGINES AND A RARE DOUGLAS DC-3 AIRLINER. IN ADDITION, THE MUSEUM'S THEATER FEATURES THE SPIRIT OF AMERICAN, A FILM, FEATURING THE HISTORY OF COMMERCIAL AVIATION AS WELL AS BREATHTAKING AERIAL PHOTOGRAPHY. THE MUSEUM RUNS A SUMMER CAMP WITH TEACHES CHILDREN ABOUT AVIATION HISTORY, HOW AIRPLANES FLY, HOW AIRLINES ARE OPERATED, ETC. THE MUSEUM CONDUCTS EDUCATIONAL LECTURES AND OPERATES A GIFT SHOP WHICH SELLS ITEMS RELATED TO THE HISTORY OF THE AIRLINE INDUSTRY. THE CR SMITH MUSEUM HOSTED 48,519 OF VISITORS IN 2012 FROM 47 STATES AND 44 COUNTRIES. RECORDS INDICATE THAT 6,206 VISITORS WERE ON FIELD TRIPS, 90% OF THOSE FROM SCHOOLS AND DAY CARES.




