The Client Services Program provides free pregnancy testing for all applicants. Limited obstetrical ultrasound is used for verification of viable pregnancy and each client is given information on all options by well-trained advocates. Clients are provided with prenatal vitamins, maternity clothes and baby clothes as needed. Some of the clothing is purchased by PHCCV, but most is donated. Clients may also earn additional items such as cribs, car seats, bouncers, strollers, high chairs and diapers by attending prenatal and parenting classes. A 24-hour helpline and a post-abortion support group are also offered. All services provided are free to our clients. The service of washing and mending donated items is also donated and valued at 2,400 per year.
