The organization has plans to further expand their efforts to solicit funds from the general public in the future by increasing their telephone bank. They also have plans to expand their print advertising effort in order to obtain more funds by printing and distributing pamphlets to the general public about the organization's charitable goals and accomplishments. Other possible expansion would include advertising in the print media. The organization realizes that with the current economic conditions greater emphasis must be placed on obtaining funds from the general public.
