After applying, UMC Holding, Inc. tax exempt status was reinstated under 501(c)(2) and a 990 was required to be filed since revenue agents were not compelled to rule UMC Holding, Inc. a Governmental Entity (see attached).

During the application process, it was determined that the amounts reported by the general partner on the Premier Purchasing Partners, L.P. (UMC Holding, Inc. is a limited partner in this Limited Partnership) as unrelated business income (UBI) were actually not UBI due to UMC Holding, Inc. being a 501(c)(2) and all the proceeds being forwarded to a Governmental Entity parent, Lubbock County Hospital District, dba UMC Health System who is in the business of medical care and the UBI reported by from Premier Purchasing Partners, L.P. on the K-1 was non-member dues in a medical supply purchasing group.

The revenue agent could not have granted an exemption under 501(c)(2) if these amounts were considered unrelated business income because it is prohibited for a 501(c)(2) to received UBI.
