HIV Testing Program - HIV testing program for individuals at high risk for HIV transmission. A total of 213 tests were performed and 5 individuals were newly identified as HIV positive. These individuals were subsequently linked with primary medical care to ensure the impact of HIV on their health was mitigated.

HIV Prevention - HIV prevention programs included the Popular Opinion Leader program and Brother to Brother programs, both of which have been proven to reduce the transmission of HIV in targeted populations by the Centers for Disease Control.
POL program reached 761 individuals and graduated 60 POL Leaders. Leaders conducted 505 targeted HIV prevention conversations with at-risk individuals. The two day program was held 10 times throughout the year.
68 individuals graduated from the three day Brother to Brother program. The program was held 11 times during the program year and all graduates demonstrated proficiency in reducing their own personal risk for HIV and their ability to communicate risk factors to members of their social networks.
