

LEAP is dedicated to enhancing and enriching the lives of people around the world by providing specialized medical and surgical services in the love of Christ.

LEAP actively plans and carries out medical mission trips through the coordination of teams of U.S. based medical professionals and the provision of these teams to underdeveloped countries. LEAP's teams often work with other organizations within a country to be able to provide surgical and medical services that would otherwise be unavaialble to the countries' residents. During 2012, LEAP hosted a total of 7 mission trips to 5 countries, including Haiti, Belize, Ecuador, India & Zimbabwe, serving more than 300 children by performing general and specialized surgeries, including cleft lip and palate, craniofacial, urology, ophthamology, ear and hand surgeries, that enhanced the quality of each child's life.

LEAP's Landmark Program brings the most difficult surgical cases from all over the world to the United States to receive specialized treatment that would not be possible in the child's home country. LEAP serves the Landmark Children by assisting in finding foster homes during their medical journey and providing emotional and financial support for the child and the foster family during this time. LEAP's medical team and medical partners also assist in providing medical procedures, supplies and medicine for free or at a significantly reduced rate. In 2012, LEAP served 5 children through the Landmark Program.

LEAP responds to worldwide disasters through the International Disaster Relief Program by offering the resources needed to be on site and ready to respond in the days immediatly following the initial search and rescue following a large scale disaster. In 2012, LEAP focused on developing and growing the International Disaster Relief Program by collaborating with the International Society of Aesthetic Plastic Surgery and undergoing significant training in disaster relief.
